Birth Certificates of Applicants Born Prior to 1960

The Department of the Registrar General has informed, by its letter No. RG/MBD/1/Circular (V2) dated 06.09.2022, that certified copies of Birth, Marriage, and Death Certificates issued by the Registrar General's Department do not become invalid after a period of 06 months, and that such documents remain valid for any period of time.

02. Therefore, in respect of senior citizen applicants born prior to 1960, if the original birth certificate (issued by the Department of the Registrar General) submitted along with the application for the National Identity Card is in a clear and undamaged condition, action can be taken to issue the National Identity Card based on that birth certificate. (It is not necessary to submit a recently obtained birth certificate.)
