#### Submission of a Police Report when applying for the National Identity card

When applying to obtain a duplicate of a National Identity Card in the event of loss of a National Identity Card, the police report submitted by an applicant who has been issued a new 12-digit National Identity Card number must include in the police report the new 12-digit National Identity Card number, and if such an applicant has submitted a previously obtained National Identity Card number comprising the letter V or the letter X along with the police report, necessary instructions should be given to correct the police report.

- 02) Further, if an applicant has forgotten the national identity card number at the time of submitting the police report, the police report should state "cannot remember the number."
- 03) Therefore, I kindly request you to notify all the Grama Niladharis from now on to check whether the National Identity Card number of the applicant is correctly mentioned in the police report submitted along with the applications to prepare lost National Identity Cards, and further please be informed that the original of the police report should be submitted to this department.
